**I. Foundation Membership: (For Chambers of Commerce)**

- (a) **Annual-** (Rs.5,000/- per annum+Rs.500 One time fee + GST Rs. 990/- = Rs. 6,490/-)  
(b) **Permanent-** 12 times the annual subscription in lumpsum (Rs.60,000 + Rs.500/- One time fee + GST Rs.10,890/- = Rs. 71,390/-)

**II. Ordinary Membership: (For Trade Associations, Commodity Boards etc.)**
